

Waiver and Release of Liability

In consideration of _____, my minor child/children ("My Child"), being allowed to participate in any way, in the Centre Dynamic Elite All-Star's program, related events, competitions and activities, the undersigned acknowledges, appreciates and agrees that :

1. Gymnastics and cheerleading are vigorous sporting activities involving height and rotation in a unique environment, and, as such pose a significant risk of injury. Gymnastics/cheerleading and related activities always involve certain risks, including but not limited to death, serious neck and spinal injuries, and serious injury to bones, joints, and muscles. The risk of such harm may be limited by safety equipment and coaches, but will never be eliminated.

2. For myself, spouse, and my child, I knowingly and freely assume all such risks, both known and unknown, and even if arising from negligence of Centre Dynamic Elite All-Stars or CoPA and their employees, and assume full responsibility for my child's participation.

3. I willingly agree to comply with Centre Dynamic Elite All-Star's and CoPA's standard and customary terms and conditions for participation in Centre Dynamic Elite All-Star's programs. If I observe any unusual and significant concern in my child's readiness for participation and/or in the Centre Dynamic Elite All-Star's program itself, I will remove my child from participation and bring such issue to the attention of the nearest CoPA personnel immediately.

4. I myself, my spouse , my child, and on my behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE CENTRE OF PERFORMING ARTS , IT'S EMPOLYEES, TEACHERS, COACHES, AGENTS, SUBCONTRACTORS, OTHER PROGRAM PARTICIPANTS, SPONSORING AGENCIES, SPONSORS, ADVERTISORS, AND IF APPLICABLE, OWNERS AND LESSORS OR PREMISSES USED TO CONDUCT CENTRE DYNAMIC ELITE ALLSTARS PROGRAM ("releases") , with respect to any and all injury, disability, death, or loss or damage to personal property incident to my child's involvement or participation in Centre Dynamic Elite All-Star/CoPA programs, whether arising from the negligence of the Releases or otherwise, to the fullest extent permitted by law.

I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin HERBY INDEMNIFY AND HOLD HARMLESS AND CONVENANT NOT TO SUE all of the above Releases, from any and all liabilities incident to participation and involvement in Centre Dynamic Elite All-Star/CoPA's programs, even if arising from the negligence of Releases, to the fullest extent permitted by the law.
